Application must be accompanied by <u>non-refundable</u> application fee of 10% of the annual dues. The fee will be applied toward dues once membership is approved. "Corporation" may pay dues in full with application or they may sign up for payment plan via electronic fund transfer (EFT) with the entire dues amount to be paid by March 1st of the membership year. If application for membership is accepted, the "Corporation" agrees to pay dues for the entire membership year (April 2025– March 2026). The Wildwood Board of Trustees may, at its discretion, pro-rate the dues of the first membership year if application is approved after April 30, 2025. All Corporate Memberships are subject to \$150 per quarter Clubhouse minimum spending that includes both food and beverage purchases. The monthly fee will be adjusted to include the sales tax, and to accommodate for fewer payments or in the case where the "Corporation" chooses to pay more up front. The EFT option is not a monthly membership option. It is a payment plan for an annual membership.

FULL MEMBER DESIGNEE(s)

Each designee is provided a Family Golf Memberships which entitles the designee and his or her spouse and dependent children to the following privileges:

- Unlimited golf access and golf tournament participation
- All House and Social activities and Pool privileges
- Dependent children may participate in Junior Golf and Swim Team activities

GOLF VOUCHER USAGE

Each membership is allocated a number of golf vouchers. The vouchers are to be used in anyway deemed appropriate by the "Corporation". The "Member" is not required to be in attendance when the vouchers are used, except in the case where the vouchers are used during prime time. In most cases, prime time is deemed to be on weekends and holidays before noon. Vouchers can be given to employees, clients, vendors or family members. The vouchers can be used for 9 or 18 holes.

CORPORATE USAGE

The "Corporation" will receive discounted clubhouse rental rates and discounted golf outing fees. The discounts will be based on event and/or outing size and date.

The "Corporation" will be allotted one (1) free golf outing for up to 40 golfers if scheduled on a Monday during the golfing season. Cart fees and food and beverage will be extra.
